**Representatives Tiffany Roberts and Rachel Henderson
Honored with the 2025 Jim McGregor Award**

Augusta, ME (October 17, 2025) — The Retail Association of Maine (RAM) proudly presented its 2025 Jim McGregor Award to Representative Tiffany Roberts (D-South Berwick) and Representative Rachel Henderson (R-Rumford) in recognition of their collaborative leadership, bipartisan spirit, and commitment to advancing practical, balanced public policy that supports Maine's retail and business community.

Named for the late Jim McGregor, the association's longtime Director of Government Affairs, the award honors individuals who exemplify integrity, accessibility, and a deep respect for Maine's economic well-being. It celebrates those who, like Jim, bring people together to find solutions that work for all.

"Both Tiffany Roberts and Rachel Henderson have shown extraordinary dedication to the hard work of policymaking," said Curtis Picard, President and CEO of the Retail Association of Maine. "They listen, they engage, and they seek balance. Even when tackling some of the most complex and controversial issues — like data privacy and paid family leave — they've stayed focused on finding common ground and crafting legislation that truly works for Maine."

As a ranking member of the Joint Standing Committee on Housing and Economic Development, Representative Roberts has been instrumental in supporting interoperable data privacy legislation and leading efforts to improve Maine's Paid Family and Medical Leave program. Her thoughtful approach and willingness to listen have earned her deep respect from colleagues and the broader business community.

Representative Henderson has been a consistent and constructive voice on the same issues — serving as a key architect of workable data privacy policy and a tireless advocate for fair, effective regulation. Her analytical approach, attention to detail, and open communication style have made her an invaluable partner in navigating complex legislative debates that directly impact Maine employers and consumers alike.

Together, Roberts and Henderson represent the kind of bipartisan collaboration that strengthens Maine's legislative process and reflects the very spirit of the Jim McGregor Award.

"Jim always believed that policy wasn't about politics — it was about people," Picard added. "Tiffany and Rachel embody that philosophy. Their accessibility, responsiveness, and integrity make them outstanding public servants and worthy recipients of this year's award."

The Jim McGregor Award has been presented annually since 2005 to individuals who have gone above and beyond in supporting Maine's retail and business community. Previous recipients include Tom Largay (2024), Greg Dugal (2023), Dr. Amelia Arnold of Community Pharmacy (2022), Quincy Hentzel of the Portland Regional Chamber of Commerce (2021), Maine State Senator Stacey Guerin (2019), U.S. Senator Susan Collins (2013), and then-Representative Janet Mills (2006).
